The Departmental Promotion Committee (Lower) was convened on 28-12-2017 to draw up the Select List for the year 2018.

DPC reviewed the cases of supersession by the previous Departmental Promotion Committees and decided as follows:

1. Sri Babu, S. (Rank No. 4374)

The Vigilance and Anti-Corruption Bureau has registered a case against him as V.C.01/14/KLM and prosecution sanction order has also been issued as per proceedings No. LRD1-6316/14 dated 22-6-2015 by the Commissioner of Land Revenue.

The DPC (Lower) held on 15-6-2016 decided to include him provisionally in the select list for the year 2016 subject to the report of the VACB.

As the Vigilance Case is pending disposal, DPC (Lower) discussed in detail and decided to continue the status until the next DPC (Lower).

2. Sri Jayajose Raj, C. L. (Rank No. 4419)

As per the Government order G.O.(Rt.) No. 3194/2004/RD, dated 19-8-2001, LWA for study purpose was sanctioned to Sri Jayajose Raj, C. L. subject to the terms and conditions specified in Appendix XII B, Part I. K. S. R.

As per the decision of the DPC dated 15-6-2016, the Commissioner of Land Revenue has requested Government to review the order No. 1959/16/RD dated 3-3-2016. The Government as per letter No. 51829/T3/2017/RD dated 20-3-2017 informed that there is no need to review the said order.

DPC (Lower) held on 31-5-2017, discussed the matter in detail and unanimously opined that there is every possibility to attract similar representations from those who availed LWA for study purpose which may cause administrative inconvenience and affect the seniority of many employees. Accordingly the matter has again been taken up with Government. The DPC (Lower) decided to keep the present status until the next DPC (Lower).

3. Sri Gopalakrishnan, K. K. (Rank No. 4445)

V. C. 03/14/KNR has been registered against him with regard to the issuance of bogus pattayam. Prosecution sanction order not issued so far. The DPC held on 15-6-2016 decided to include him provisionally in the select list 2016. The provisional inclusion of the incumbent in the select list for 2016 is reviewed by the DPC and decided to keep the status until the next DPC (Lower).

4. Sri Mohandas, G. (DT/JS Rank No. 4531)

Vigilance case is pending against him as V.C4/14/PKD. Memo of charges for imposing major penalties has been issued by the Government as per the file No. 87014/D2/15/RD, dated 6-4-2016. Another Vigilance

case No.VC-7/14/PKD is also pending against him for taking helpful stand to the illegal conversion of land. Prosecution sanction order has not been issued. DPC (Lower) discussed the matter and as there is no change in position, decided to continue his supersession.

5. Sri Sathyaprakash, P. V. (DT/JS Rank No. 4578)

Since the incumbent has not submitted the Confidential Report, the DPC decided to continue his supersession.

6. Sri Jithesh Babu, K. T. (Rank No. 4644)

The incumbent failed to submit the Confidential Report. Hence DPC decided to supersede him.

7. Sri Shajahan Rawther (Rank No. 4649)

Disciplinary action initiated by Government is pending against him. Memo of charges for major penalty has been issued on the ground of illegal issue of Pattayam. (Govt. File No. 3344/D1/16/RD & CLR File No.LRD7-9826/17). Hence the DPC decided to supersede him.

8. Smt. Geetha, K. G. (Rank No. 4670)

The incumbent has not submitted the Confidential Report. Hence the DPC decided to supersede her.

9. Sri Bharathan, V. V. (Rank No. 4700)

Disciplinary action was initiated and memo of charges for major penalty issued against him by the Government on the ground that no action was taken to prevent the filling of soil on the wetland and no follow up action was taken on the petition submitted by the Secretary, Ponnani Taluk Paddy Field Protection Council. The disciplinary action initiated against him has been finalized by Government by barring two annual increments without cumulative effect as per G. O. (Rt.) No. 2573/16/RD, dated 17-6-2016. Since the currency period of the penalty is not completed, the DPC (Lower) decided to supersede him.

10. Smt. Jaya, V. C. (Rank No. 4794)

The incumbent has not submitted the Confidential Report, hence the last DPC decided to supersede her. Now she has submitted the report.

Disciplinary action has been initiated against her by the District Collector, Alappuzha and Mémo of charge for major penalty has been issued. Hence, the DPC (Lower) decided to supersede her.

11. Smt. Suma, K. S. (Rank No. 4795)

The incumbent has not submitted the Confidential Report. Hence the last DPC decided to supersede her. Now she has retired from service and hence the DPC (Lower) decided to exclude her from Field of choice for the year 2018.

12. Sri Ramasan, P. V. (Rank No. 4815)

The incumbent has not submitted the Confidential Report. Hence the DPC (Lower) decided to supersede him.

13. Smt. Bindu, P. G. (Rank No. 4867)

The incumbent has not submitted the Confidential Report. Hence the last DPC decided to supersede her. Now confidential report submitted. Hence the DPC (Lower) decided to include her in the field of choice for the year 2018.

14. Smt. Sunitha Jacob (Rank No. 4882)

The incumbent has not submitted the Confidential Report. Hence the DPC decided to supersede her.

15. Sri Ani, B. P. (Rank No. 4886)

Memo of charges for major penalty on account of the issue of possession certificate, has been issued to him by the District Collector, Kollam and the incumbent has submitted the Confidential Report. The DPC (Lower) decided to supersede him.

16. Sri Sabu, M. G. (Rank No. 4925)

Two vigilance cases No. VC-14/08/IDK and VC-06/07/IDK are pending against him. Prosecution sanction has been issued in both cases. Hence the DPC (Lower) for 2017 has decided to supersede him. As there is no merit, the DPC (Lower) decided to continue his supersession.

The Departmental Promotion Committee considered the requests of N. Rajendran Asari, Sri M. Babu, Smt. Aniamma Varghese and Smt. Anitha, R. and decided hereunder.

1. Sri N. Rajendran Asari (DT/JS No. 4062)

There was a Criminal case No. CC 406/14 (Crime. No. 44/13) in Punalur Police Station against the Sri N. Rajendran Asari in connection with strike relating to Contributory Pension. The DPC (Lower) held on 17-3-2015 decided to include him provisionally in the select list for the year 2015, subject to the final decision of criminal case. Now, he has submitted the final judgment in the said case. As per that the case No. CC 406/14 (Crime No. 44/13) in Punalur Police Station was withdrawn by the Government and the Hon'ble Judicial Magistrate of the First Class (Forest Offences), Punalur in the judgment in CRL. MP No. 2277/17 in CC. 406/2017 dated 5-10-2017 allowed it and disposed the case. In these circumstances, he has requested to rearrange his position and include him in the select list for the year 2013.

DPC (Lower) discussed in detail and decided to include him in the select list 2013 as Sl. No. 60A in between Sl. No. 60-Anilkumar, P (4054) and Sl. No. 61-Karthiayani Devi, C. R. (4063).

2. Sri M. Babu (DT/JS Rank No. 4591)

A criminal case vide No. 56/13 has been registered against him under Section 118, 120(b), 143, 147, 148, 149, 294(b), 323, 341 of IPC. He is the 9th accused in the above criminal case.

In this case, he was placed under suspension by the District Collector, Idukki vide proceedings No. SS2-6455/13 dated 14-2-2013, in connection with the strike of Government servants. Subsequently he has been re-instated in service by the District Collector, Idukki vide proceedings No. SS2-6455/2013 dated 6-7-2013. Memo of charge not issued.

In the judgment in OA(EKM)-3061/17 dated 22-12-2017, the Hon'ble Kerala Administrative Tribunal ordered to consider the eligibility of the applicant for selection and appointment to the post of Tahsildar and if the

only objection against considering his eligibility is the non availability of the confidential reports for the three year period, the committee shall resort to the provisions in Rule 28(b)(i)(4)(b) of Part II KS&SSR.

The DPC (Lower) discussed in detail and decided to include him in the Select list for the year 2018, provisionally as Sl. No. 1. The DPC (Lower) also decided that the provisional inclusion will be subject to decision of the Government as per the final order in OA-964/2013.

3. Smt. Aniamma Varghese (DT/JS No. 4617A)

Smt. Aniamma Varghese (DT/JS No. 4617A), whose seniority has been refixed as 4617A and date assigned as 18-11-2010 as per the order of Hon'ble Kerala Administrative Tribunal. Probation in the DT/JS cadre also declared as on 21-3-2013. Now she has submitted the Confidential Report. There is a direction of Hon'ble Kerala Administrative Tribunal as per the judgment in OA(EKM) No. 441/2017 to consider her in the DPC (Lower).

The DPC (Lower) discussed in detail and decided to include her in the select list for the year 2017 as S1. No. 10A in between S1. No. 10-Devaki, K. (4614) and S1. No. 11-Elvin Antony Fernandez (4618).

4. Smt. Anitha, R. (DT/JS Rank No. 4688)

Higher survey is one of the qualifications as per the special rules of the Kerala Revenue Service (Tahsildar). As per G. O. (Ms.) No. 357/2017/RD dated 25-10-2017 the differently abled persons are exempted from passing Higher survey for the promotion to the cadre of Tahsildar. This exemption came into force w.e.f. 25-10-2017.

Smt. Anitha, R. is an approved probationer whose probation was declared on 2-2-2014 on the basis of Rule 13b of KS&SSR Part II. She passed Criminal Judicial Test on 21-4-1995.

The DPC (Lower) discussed in detail and decided to include her in the Select list for the year 2017 as Sl. No. 71C(A) between Sl. No. 71C- Motilal, G. (4673) and Sl. No. 71D-Saji, P. (4717)
