The Kerala Revenue Service (Tahsildar) Special Rules amended as per Government Order read as 1st paper above, states that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be one year on duty within a continuous span of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training for eight weeks before declaration of probation as emphasized under Rule 8 of Special Rules (Tahsildar).

As per the letters read as paper 2 to 9, the District Collectors/Head of Offices concerned have submitted proposals for the declaration of probation of Tahsildars/ Senior Superintendents who have satisfactorily completed Police and Magisterial training.

In these circumstances, the Probation of the Tahsildars/Senior Superintendents given in the list appended to this proceedings, are declared to have satisfactorily completed on the Forenoon of the dates shown against their names in Column No.13.




