As per the Hon'ble Kerala Administrative Tribunal's Order read as 5th paper above, quashed the Government Order, extending the period of probation of 112 incumbents in the cadre of Deputy Tahsildar/ Junior Superintendent read as 1st paper above, and directed the Government to pass fresh orders after hearing the applicants, the beneficiaries of Annexure A15 order and others who are likely to be affected by that decision, to file representation containing their contentions.

As per the Hon'ble Kerala Administrative Tribunal's Order read as 6th paper above, quashed the Annexure A3 (read as 3rd paper above) to the extent it extends the probation of the respondents 4 to 10 in OA 1664/2012 and inclusion of them in the Annexure A4 select list read as paper 4th above, and ordered that "Since the applicant is retiring on 30/11/2012 his claim for promotion based on his rank in Annexure A2 shall be considered and orders passed by the 1st respondent, if he is otherwise eligible as expeditiously as possible at any rate, before his retirement from service. The Government will be free to

pass fresh orders on the claim of the party respondents for extension of their probation, after affording an opportunity of being heard to both sides as directed in OA-333/12."

In accordance with the directions read as 6th and 7th paper above, issued promotion order to the applicant in OA -1664/12 and 3 others in the cadre of Tahsildar vide 8th paper above.

As per the directions of the Hon'ble Kerala Administrative Tribunal read as paper 5th and 6th above, the Government have passed fresh orders read as 9th and 10th paper above, extending the period of probation in the cadre of Deputy Tahsildar/ Junior Superintendent. There after the Commissioner has reviewed probation of 122 incumbents read as 11th paper above. Since the dates of declaration of probation of the incumbents have not been changed, the DPC held on 16/01/2013 decided to retain the incumbents in the same positions that got in the select lists drawn and published vide LR E2-43300/2011 dated 15/03/2012 and 30/07/2012 read as 12th paper above.

Hence following Deputy Tahsildar/ Junior Superintendent who were included in the select lists as per the papers read as 2nd, 4th and 12th above are hereby promoted to the cadre of Tahsildars / Senior Superintendents on provisional basis under Rule 28(b) (i) of the Kerala State and Subordinate Service Rules and posted in the offices noted against their name.
