The seniority lists of various categories in Land Revenue Department are subject to revision pursuant to the judgment read as ^{3rd} paper above. Hence the promotions in the Department was at a standstill which badly affected the day today administration. In the judgment dated 8/12/09 in WP(c) No. 30398/09(i) read as 12th paper above the Honorable High Court observed that *“Overload of duties and responsibilities being thrust on revenue officials including by lending their service for different other purposes relatable to Revenue ,has to be taken immediate stock of, so that the situations stated by the Principal Secretary in the Revenue Department are liquidated at the earliest. This is immediately required in public interest”*. The Honourable High Court has directed the Government *to do the needful forthwith by seriously considering the above facts.”* At present 37 posts in the cadre Tahsildars/ Senior Superintendents are vacant due to Promotion in Dy.Collector cadre ,Creation of new posts ,Deputation and Leave in Land Revenue Department. Keeping these posts vacant for a long time will adversely affect the entire district Civil/Revenue Administration such as census of India., Election Process, Land Acquisition ,Disaster Management, Issuance of Patta etc. Considering the emergent situation,the Govt. have issued sanction for temporary promotion by lifting existing ban on temporary promotions issued in cicular No.19305/Rules

1/96/P&ARD dated 09/09/1997 with the approval of the competent authority as per GO read as 1st paper above.

Considering the emergent situations stated above, it is ordered that as directed by the Government in GO read as 1st paper above the following Senior most Deputy Tahsildars who are included in the final seniority list published vide the proceedings read as 6 & 7th paper cited and those who acquired the necessary test qualifications prescribed in the GO read as 2nd cited are promoted on temporary basis to the cadre of Tahsildar on a pay scale of Rs .10790 -18000 as per the proviso to Rule 31 (a)(i) of KS&SSR 1958 and allotted to the district /offices noted against each.

The above Tahsildars/Sr.Supdt are promoted on condition that the above promotion will not confer them any right other than the right of emoluments attached to the post.

The District Collectors/Head of Officers will relieve /issue suitable posting orders to the individuals except those who are directly connected with the revision

of Electoral Roll under the intimation to this office. The transfer of officials like ERO who are directly connected to the revisional process should be effected only after obtaining necessary concurrence from Election Commission of India by the District Collector.
