In the judgment in WP(C).19076/08/U, the Hon'ble High Court of Kerala has directed the Principal Secretary to Government and the Commissioner of Land Revenue to prepare seniority lists of the feeder categories of Deputy Tahsildars based on the judgment in W.A.789/88 dated 21-03-1991 and W.A No. 162/91 dated 06-04-1995 as per which HC / RI / VO, UDC / SVO, LDC / VA are identified as the feeder categories of the post of Deputy Tahsildar. Pursuant to these, seniority lists of the feeder categories of Deputy Tahsildars were revised and finalized.

During the course of time, considering the administrative exigencies, sanction has been accorded by Government for temporary promotion to the post of Tahsildars vide G.O(Rt) No. 2593/2008/RD dated 08/08/2008, G.O(Rt) No.2361/10/RD dated 15/05/2010 and G.O(Rt) No.4902/10/RD dated 16/11/2010. In the interim order dated 06-04-2010 of the Hon'ble High Court in WP(C) No.8123/10 and connected cases, the Hon'ble High Court has allowed temporary promotions. Accordingly temporary promotions were granted to 241 incumbents who were included in the feeder categories

of Deputy Tahsildars vide proceedings read as 2 to 10 above. Temporary promotions were given as per Rule 31(a) (i) of Part II K.S & S.S.R and subject to out come of the writ petitions. Rule 31(a) (i) of K.S & S.S.R envisages that where it is necessary in the public interest owing to an emergency that which has arisen to fill immediately a vacancy in a post borne on the cadre of higher category in a service or class by promotion from a lower category and there would be undue delay in making such promotion in accordance with the rule, the Appointing Authority may promote a person otherwise than in accordance with the rules, temporarily. Also Rule 31(d) of K.S & S.S.R envisages that a person promoted under Rule 31(a) (i) shall not be regarded as a probationer in the higher category or be entitled by reason only of such promotion any preferential claim to future promotions to such higher category.

It is made clear that the promotion proceedings itself that the promotions granted to the incumbents are on temporary basis and liable to be reviewed by the DPC on the basis of seniority list of DT / JS. Moreover it is also made clear that their promotion would not confer them any right other than the right of the emoluments attached to the post.

In the common judgment in WP(C).7711/09 and 29910/08 dated 27/09/2011 the Hon'ble High Court has observed that

“Depending on the seniority list so prepared, persons who got promotion contrary to the principles must be reverted and those who are denied promotion must be given promotion.”

“Court observed that select list published on 20/01/2007 shows that the selection is subject to the final outcome of WP(C)”

“The above promotions will be provisional subject to the result of Writ petition”

Based on the said judgment seniority list of Deputy Tahsildars for the period from 01/01/1998 to 31/12/2008 has revised and finalized. Accordingly approved probationers list has been prepared. Based on the final seniority list and approved probationers list of Deputy Tahsildar, select list of Deputy Tahsildar for the period from 2008 to 2011 was drawn from the eligible for appointment to the post of Tahsildar.

The Hon'ble High Court of Kerala had also observed that the select list published would be subject to final outcome of the pending writ petitions. Therefore the select list published earlier by convening DPC cannot be treated as final.

Based on the revised seniority list of Deputy Tahsildars for the period from 01/01/1998 to 31/12/2008, the select lists drawn earlier on the basis of previous seniority lists has been revised.

In the revised select lists for the year 1.1.2003 to 31.12.2007 published vide notification read as 11th paper above, the following officers who were superseded and

now acting as Temporary Tahsildars are reverted to the cadre of Deputy Tahsildar and posted in the Office/District Noted against their name.
