The vacancies that arose in the cadre of Deputy Tahsildar/Junior Superintendent for the period from 01.01.2007 to 31.12.2008 have been assessed and published vide the reference read as 1st paper above.

An objection has been received alleging that some of the newly created vacancies in the cadre of Deputy Tahsildar/Junior Superintendent that related to the period from 01/01/2007 to 31/12/2008 have not been taken into account while the vacancies were assessed. Accordingly, the same details have been got verified through the District Collectors vide letters read as 3 to 9 accordingly. Moreover, the total vacancies of DT/JS newly created in Revenue department during the period 01.01.2007 to 31.12.2008 have been reported by the Assistant Commissioner (RE) vide the reference read as 10th paper above.

Based on the above reports, it is found that a total number of 24 newly created posts in the cadre of DT/JS have been excluded in the assessment done vide ref(1), as follows.

01.01.2007 to 31.12.2007	:	15
01.01.2008 to 31.12.2008	:	<u>9</u>
Total	:	<u>24</u>

In the circumstances, the total number of vacancies that arose or were created in the cadre of Deputy Tahsildar/Junior Superintendent for the period from 01/01/2007 to 31/12/2008 are re-assessed as 496 as follows:

01.01.2007 to 31.12.2007	:	320
01.01.2008 to 31.12.2008	:	<u>176</u>
Total	:	<u>496</u>
