**ORDER**

Government as per G.O. read as 1<sup>st</sup> paper above accorded sanction for the continuance of Special Land Acquisition Units up to 31-03-2015.

The Commissioner, Land Revenue as per letter read as 2<sup>nd</sup> paper above submitted a detailed proposal for the continuance of the above units for one year from 01/04/2015.

Government have examined the matter in detail and are pleased to accord continuance sanction to 106 posts attached to 9 Land Acquisition Units created for land acquisition for railway in the State as per details appended to this order subject to following conditions:

- i) 6 Land Acquisition Units at Thiruvananthapuram, Kollam, Ernakulam, Perumbavur, Guruvayoor and Tirur shall be closed down as on 31/08/2015.
- ii) The staff of these units will take urgent necessary action to hand over residual works in each of these units to the respective LA General Units.
- iii) the Commissioner, Land Revenue will issue orders of re-deployment of these posts and shall ensure the residual works are attached to the general units concerned.
- iv) continuance sanction to L.A. Units at Kayamkulam, Pala and Kottayam are accorded up to 31/07/2015.

The Commissioner, Land Revenue shall review the quantum of balance works in each unit and submit specific report on the functioning of the Special Land Acquisition Units constituted for land acquisition for railway. The Commissioner, Land Revenue /District Collectors will take urgent action to get the establishment charges, if any pending from railways.


