S. R. O. No. 651/2014.—In exercise of the powers conferred by section 7 of the Kerala Government Land Assignment Act, 1960 (30 of 1960), the Government of Kerala hereby make the following rules further to amend the Arable Forest Land Assignment Rules, 1970.

RULES

1. *Short title and commencement.*—(1) These rules may be called the Arable Forest Land Assignment (Amendment) Rules, 2014.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Arable Forest Land Assignment (Amendment) Rules, 1970, in rule 5,—

(a) in the opening sentence, for the letters and figures “Rs. 3,000”, the letters and figures “Rs. 75,000”, shall be substituted;

(b) in the first proviso, for the letters and figures “Rs. 6,000”, the letters and figures “Rs. 1,50,000”, shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the Arable Forest Land Assignment Rules, 1970, the annual family income limit for eligibility for assignment of land to a person whose family does not own or hold more than ten cents of land is Rs. 3,000 only and in the case of disabled defence personnel, dependants of defence personnel killed and Ex-servicemen whose families own or hold land not more than once acre is Rs. 6,000 only. Considering the enhanced income of the prospective assignees with passage of time, the Government have decided to enhance the said annual family income limit for assignment to Rs. 75,000 and Rs. 1,50,000, respectively.

The notification is intended to achieve the above object.
