Sub :- Establishment – Land Revenue Department – Declaration of Probation in the cadre of Tahsildar/Senior Superintendent – orders issued

In accordance with Government Orders read as 1st and 2nd paper above, Kerala Revenue Special Rules are published. Rule 7 of Kerala Revenue Service (Tahsildar) Special Rules as per Government Order read as 2nd paper above, stipulates in that, every person appointed as Tahsildar, shall from the date on which he/she joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

According to Rule 8 of Kerala Revenue Service (Tahsildar) Special Rules read as 2nd paper above, every person appointed as Tahsildar, shall, before declaration of completion of his/her probation successfully, undergo Magisterial Training for eight weeks (6 weeks in Police Department and 2 weeks in Judicial Department) as detailed in annexure to these rules, if he has not undergone the training before appointed to the service.

The Kerala Revenue Service (Tahsildar) Special Rules amended with regard to Government Order read as 3rd paper above, envisaging that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be as one year on duty within a continuous span of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation as emphasized under Rule 8 of Special Rules (Tahsildar).
