Sub :- Establishment – Land Revenue Department – Declaration of Probation in the cadre of Tahsildar/Senior Superintendent– orders issued

The Kerala Revenue Service (Tahsildar) Special Rules amended as per Government Order read as 1<sup>st</sup> paper above, the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be one year on duty within a continuous span of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training for eight weeks before declaration of probation as emphasized under Rule 8 of Special Rules (Tahsildar).

The District Collector, Palakkad has submitted proposals read as number 2 and 3 above, for the declaration of probation in the cadre of Tahsildar/ Senior Superintendent in respect of Sri.Mnoharan.P.G and Sri.Manikandan.K, who have completed Police and Magisterial Training. In the proposal read as 2<sup>nd</sup> above it is also requested to extend the period of probation up to 11.10.2016, since Sri.Manoharan P G delayed for completing the P&M training.In the letter read as 4<sup>th</sup> cited,District Collector, Thiruvananthapuram has submitted proposal for the declaration of probation in respect of Sri.M.Khaleelur Rahman, who have completed P&M training.

Considering the request submitted by the District Collector, Palakkad, the probation period in respect of Sri.Manoharan P G is here by extended up to 11.10.2016.

On examination of the above reports as stated, the Probation of Tahsildars/Senior Superintendents named below have satisfactorily completed probation in the Forenoon of the dates that shown against their names in Column No.9.
