Consequently, a revised final seniority list of Tahsildars from 01-04-01 to 31-12-10 were published vide 2nd paper read above. In accordance with that list, Senior/ Higher Grade of Tahsildar /Senior Superintendent up to 05/07/2014 (Tahsildar Rank No 1141) had been sanctioned as per proceedings read as 3rd to 5th above.

The 20% of the sanctioned strength in the cadre of Tahsildar up to 31-01-2011 are in Tahsildar Higher Grade /Senior Grade and as per Government Order read as 1st paper above, the Higher Grade /Senior Grade of the Tahsildar has been enhanced from 20% to 25% w e f from 01-02-2011.
