On account of the Government Orders read as 1st and 2nd above, Kerala Revenue Service Special Rules were published. Rule 7 of Kerala Revenue Service (Tahsildars) Special Rules published as per Government Order read as 2nd above, envisaged that every person appointed as Tahsildar, shall from the date on which he/she joins duty, on probation for a total period of two years on duty within a continuous period of three years.

Rule 8 of the Kerala Revenue Service (Tahsildar) Special Rules read as 2nd, emphasizing that every person appointed as Tahsildar, shall, before declaration of completion of his/her probation successfully, undergo Magisterial training for total period of 8 weeks (6 weeks in the Police Department and 2 weeks in the Judicial Department) as detailed in the Annexure to these Rules, if he has not undergone the training before appointment to the service.

The Kerala Revenue Service (Tahsildar) Special Rules amended as per Government Order read as 3rd above, stipulated that the period of declaration of probation in the post of Tahsildar/Senior Superintendent shall be as one year on duty within a continuous period of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation as envisaged under Rule 8 of the Special Rules.

The District Collectors submitted proposals for declaration of probation of the followings officers in the cadre of Tahsildar/Senior Superintendents who have completed Police and Magisterial Training during the course of probation. On examination of the reports submitted by the District Collectors, probation of the officers appended to the list are eligible to be declared on the date noted against their name, in the cadre of Tahsildar/Senior Superintendent.

In accordance with the references read as 1 to 4 above, probation in the cadre of Tahsildar/Senior Superintendents enclosed in the list are declared to have satisfactorily completed in the forenoon of the date as shown in the column number nine of the list.



With regard to the Government Orders read as 1st and 2nd above, Kerala Revenue Service Special Rules were published. Rule 7 of Kerala Revenue Service (Tahsildars) Special Rules published as per Government Order read as 2nd above, emphasizing that every person appointed as Tahsildar, shall, from the date on which he/she joins duty, be on probation for total period of two years on duty within a continuous period of three years.

Rule 8 of the aforementioned Kerala Revenue Service (Tahsildar) Special Rules envisaged that every person appointed as Tahsildar, shall, before declaration of completion of his/her probation successfully, undergo Magisterial training for 8 weeks (6 weeks in the Police Department and 2 weeks in the Judicial Department) as detailed in the Annexure to these Rules, if he/she has not undergone the training before appointment to the service.

On account of Government Order read as 3rd above, Kerala Revenue Service (Tahsildar) Special Rules were amended, envisaging that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be as one year on duty within a continuous period of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation as emphasized under Rule 8 of the Special Rules.

In compliance with verdicts of Hon'ble Courts, Government Orders and Rule 28 (b) (i) of K.S. & S.S.R 1958, all temporary promotions in the cadre of Tahsildar/Senior Superintendents for the period from 01-04-2001 to 31-12-2010 have been regularised vide proceedings read as 4th above and the final seniority list of Tahsildar/Senior Superintendent for the aforesaid period have been drawn and published as per proceedings read as 5th above.

Sri. K. P. Kaladhara kumar and Sri. Vinod. M.P. have been promoted as Tahsildar/Senior Superintendent as per proceedings No. LRE2-43300/11 dated 08-02-2013 and joined duty, on 13-02-2013 and 18-02-2013 respectively by virtue of promotion. The District Collector, Thiruvananthapuram as per letter read as 6th above submitted proposals to declare probation successfully of the aforementioned officers in the cadre of Tahsildar/Senior Superintendent. On examination of the report submitted by the District Collector, their probation commenced from 13-02-2013 and 18-02-2013 respectively. However, the officers have completed Police and Magisterial Training on 20-03-2015. As per the Government Order read as 3rd, the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be as one year on duty within a continuous period of two years, and stipulated that the person who is appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation by virtue of Rule 8 of the Special Rules. But Sri. Kaladhara kumar. K.P. and Sri. Vinod. M.P. have not underwent Police and Magisterial Training within a continuous period of two years.

Rule 21 of K.S. & S.S.R. 1958, empowers the Appointing Authority to extend the period of probation for one year, if found necessary. Since Sri. Kaladhara kumar. K.P. and Sri. Vinod M.P. have completed Police and Magisterial Training on 20-03-2015, their period of probation has extended up to 21-03-2015 AN by Land Revenue Commissioner as per proceedings read as 7th above.

Having regard to the facts as examined, probation of Sri. Kaladhara kumar. K.P. and Sri. Vinod. M.P. in the cadre of Tahsildar/Senior Superintendent is declared to have satisfactorily completed in the forenoon of 21-03-2015. Details are shown in the annexure appended to the order.
