NOTIFICATION

No. LR. E2-20300/2016. Dated, Thiruvananthapuram, 15th June, 2016.

The Ad hoc Departmental Promotion Committee (Lower) held on 28th July, 2015 drew the select list for the year 2015 and published the same vide notification No. LR E2-14/2014 dated 4th August, 2015.

The Departmental Promotion Committee (Lower) was convened on 15th June, 2016 to draw up the select list for the year 2016.

The Departmental Promotion Committee (Lower) reviewed the cases of supersession by the previous Departmental Promotion Committees and decided as follows:

**1. Sri Mohammed Noushad, P. (DT Rank No. 3299)**

Sri Mohammed Noushad has been sentenced to undergo rigorous imprisonment for a period of four years and to pay a fine of ₹ 50,000 by the Hon'ble Court of the Enquiry Commissioner and Special Judge, Kottayam in CC 242/08 dated 30-9-2013. On the basis of the above verdict he has been placed under suspension by the Commissioner of Land Revenue vide proceedings No. I.R. D5-44973/13, dated 28-11-2013. Show cause Notice under Section 18 of KCS (CC&A) Rules, 1960 has been issued against him by the Government vide No. 66178/D1/13/RD, dated 21-4-2014. The Committee decided to continue his supersession.

**2. Sri Vidyodayakumar, T. (DT Rank No. 4112)**

On the basis of the allegation of mis-utilization of Tsunami fund, an enquiry conducted by the Vigilance and Anti Corruption Bureau, found that Sri Vidyodayakumar former Village Officer of Kazhakoottam Village claimed bogus bills for setting apart the charges related to the Tsunami Relief Camp 2004-2005. In accordance with above report, the Government have issued Memo of Charges for imposing minor penalties vide proceedings No. 63428/D1/12/RD, dated 2-9-2013. Disciplinary action has been finalized by awarding a "Censure" vide G. O. (Rt.) No. 2748/15/RD, dated 29-5-2015.

The disciplinary action initiated against him in connection with Kadakampally land grab issue has been finalized and he has been awarded major penalty by barring three increments with cumulative effect vide proceedings No. S5-72284/06, dated 29-4-2010. On appeal the Commissioner, Land Revenue modified it as two increments with cumulative effect. Challenging the above orders he has filed a review petition before the Government, which is pending before Government.

The District Collector, Thiruvananthapuram has informed that C.B.I. enquiry is going on in the same issue. Moreover Sri Vidyodayakumar was arrested by C.B.I. on Kadakampally land grab issue. He has been placed under suspension by the District Collector, Thiruvananthapuram vide proceedings No. S5-48761/15 dated 4-6-2015. He has not been reinstated so far. Also he retired from service on 31-5-2016. The Committee decided to continue his supersession.

**3. Sri Anil Kumar, B. K. (DT Rank No. 4279)**

Though the incumbent has attained the required qualification for promotion, he has not submitted the confidential report. The Committee decided to continue his supersession.

**4. Sri Jose, P. K. (DT Rank No. 4344)**

Though the incumbent has attained the required qualification for promotion, he has not submitted the confidential report in the previous DPC. But now the incumbent has submitted his confidential report and Committee considered his merit and ability and decided to include him in the select list for 2015 as serial No. 42A in between Serial No. 42 Simon Fernandes and Serial No. 43 Sudheesh, R.

**5. Sri Premachandran, H. S. (DT Rank No. 4433)**

Based on the report of Vigilance and Anti Corruption Bureau, the Government have issued memo of charges for imposing major penalties vide No. 73700/D3/12/RD, dated 29-6-2013. The disciplinary action initiated against him by the Government has been finalized by awarding him a warning vide G. O. (Rt.) No. 6456/15/RD, dated 3-12-2015. Since the disciplinary proceedings initiated against him has been finalised, the Committee considered his merit and ability and decided to include him in the select list for 2016.

**6. Sri Ramachandran, P. K. (DT Rank No. 4332)**

As per the Government Order G.O. (Rt.) No. 6220/15/RD, dated 24-11-2015 the probation of Sri Ramachandran, P. K. has been declared with effect from 4-11-2011 F. N. as per the proceedings No. LR E5-47133/15 dated 30-11-2015. He has passed Criminal Judicial Test and Higher Survey Test on 1-8-2011 and 23-11-2014 which is mandatory for promotion to the cadre of Tahsildar/Senior Superintendent. Thus he became qualified for promotion to the post of Tahsildar/Senior Superintendent on 21-11-2014 (date of declaration of results). The Committee reviewed the case, considered his merit and ability and decided to include him in the select list for the year 2015 and to be placed notionally as Sl. No. 36A in between Shri Manikandan, K. (Rank No. 4331, Sl. No. 36) and Smt. Sumathy (Rank No. 4333, Sl. No. 37).

The Committee considered the request/representations of the following officials and decided hereunder :

**(1) Smt. Nabeesa, J. (DT Rank No. 3920)**

Smt. Nabeesa filed a representation before the Government and Land Revenue Commissioner for consideration of inclusion of her name in the select list for 2012 and for getting subsequent allowances. As per the records, three cases were initiated against Smt. Nabeesa. Out of this, two cases were initiated by the Vigilance and Anti Corruption Bureau and one was initiated by the Government. She has been acquitted from CC. 18/10 and 19/10 registered by the Vigilance and Anti Corruption Bureau. The disciplinary action initiated by the Government has been finalized by awarding a "censure". The Committee considered her representation and decided to include her in the select list for the year 2012 as Sl. No. 101A in between Sl. No. 101 Shri Alex P. Thomas and Sl. No. 102 Smt. Shobi Sara Varghese and carried over to 2013 select list as her junior got promotion only in the year 2013 for getting seniority for further promotion if otherwise eligible.

**(2) Babu, S. (DT Rank No. 4374)**

The Vigilance and Anti Corruption Bureau has registered a case against him as per V. C. 07/14/KLM and Prosecution Sanction Order has also been issued as per proceedings No. LRD3-6316/14, dated 22-6-2015 by the Commissioner of Land Revenue. The case is still pending before the Vigilance and Anti Corruption Bureau. Hence the DPC (Lower) convened on 28-7-2015 has decided to supersede him.

Against the decision of the DPC (Lower) held on 28-7-2015 Shri Babu, S. filed a representation before the Land Revenue Commissioner and the Convenor, DPC (Lower) to review the decision of the DPC. This representation was disposed of with the decision that this matter will be placed before the next DPC.

The Committee considered his representation and as it is known that charge sheet has not been issued so far the committee decided to include his name provisionally in the select list 2016 subject to communication from Vigilance and Anti Corruption Bureau.

**(3) Jaya Jose Raj, C. L. (Rank No. 4419)**

As per the Government Order G. O. (Rt.) No. 3194/2004/RD, dated 19-8-2004 LWA for study purpose was sanctioned to Shri Jaya José Raj C. L. subject to terms and conditions specified in Appendix XII B, Part I, KSRS. Aggrieved by this order he filed an OA No. 1912/15 before the Kerala Administrative Tribunal requesting to review the above Government Order. The OA was disposed on 18-11-2015 with a direction to the Government to consider and pass orders on the representation of the petitioner.

The Departmental Promotion Committee (Lower) decided to shift the last 9 officers remaining in the select list 2015 for promotion to the select list for 2016. The Committee further considered the merit and ability of the officers included in the current year's field of choice and decided to supersede the following officers:

**1. Smt. N. N. Radhamony (DT/JS Rank No. 4444)**

VC-No. 13/15/KNR has been registered against her in connection with bogus pattayam in favour of K. K. N. Memorial Library and Reading Room, Pariyaram. Prosecution Sanction Order has not issued yet. Not submitted the Confidential Report. The Committee decided to supersede her.

**2. Sri K. K. Gopalakrishnan (DT/JS Rank No. 4445)**

VC-03/14/KNR has been registered against him with regard to the issuance of bogus pattayam. Prosecution Sanction Order not issued so far. The Committee decided to include him provisionally in the select list 2016.

**3. Sri Monachan (DT/JS Rank No. 4458)**

Disciplinary action for major penalty has been initiated against him vide Memo of Charge No. 30672/D1/13/RD, dated 31-10-2013 alleging the irregularities in timber auction at Kelankavu in Pathanapuram Taluk. Not submitted the Confidential Report. The Committee decided to supersede him.

**4. Sri George Mathew (DT/JS Rank No. 4489)**

Minor Memo of Charge has been issued by the Commissioner of Land Revenue vide No. LRD7-8132/03, dated 19-10-2010. Not submitted the Confidential Report. The Committee decided to supersede him.

**5. Sri Abdusalam Ammayath (DT/JS Rank No. 4515)**

Though Sri Abdusalam Ammayath was known that the land owned and possessed by Sri Lokesh Acharya (defaulter of K. S. H. B.) was taken into custody by the Government as bought in land, he concealed the same from the Notice of the District Collector, Kasaragod, while the RRC and Requisition were returned to the District Collector.

In the light of the above, Disciplinary action has been initiated by the Commissioner of Land Revenue by issuing Memo of Charges for major penalty vide No. LRD6-21833/15 dated 18-11-2015. Disciplinary action is still pending. Not submitted the Confidential Report. The Committee decided to supersede him.

**6. Sri Biju G. Krishnan (DT/JS Rank No. 4530)**

He was removed from service by the Commissioner of Land Revenue vide proceedings No. LRD3-12874/09 dated 7-8-2014 in connection with the misappropriation of Government Money. Not submitted the Confidential Report. The Committee decided to supersede him.

**7. Smt. Beena P. Anand (DT/JS Rank No. 4541)**

Disciplinary action for Major Penalty has been initiated by the Commissioner, Land Revenue as per Memo of Charge No. LRD 6-27079/15 dated 20-7-2015.

The main charge levelled against her is that, eventhough she travelled in Government vehicles, she availed the Travelling Allowance, as if she travelled in private vehicle and thus abused public money. The committee decided to supersede her.

**8. Sri Prabhullakumar (DT/JS Rank No. 4544)**

Sri Prabhullakumar, S. was trapped by the Vigilance and Anti Corruption Bureau while accepting bribe. Vigilance Case No. 03/08/KLM has been registered which is pending and the case is under trial as CC 35/09. The Committee decided to supersede him.

**9. Sri Saleendran, K. S. (DT/JS Rank No. 4546)**

Memo of Charge for major penalty has been issued against him, vide No. LRD5-21241/10 dated 30-10-2014, by the Commissioner of Land Revenue with regard to the loss sustained to the Government due to short levy of building tax, Not submitted the Confidential Report. The Committee decided to supersede him.

**10. Sri Nadarshan, V. P. (DT/JS Rank No. 4549)**

Disciplinary action for minor Penalty has been initiated against him vide Memo of Charge No. 48255/D1/14/RD dated 25-11-2014 in connection with the irregularities in quarrying. The Committee decided to include him provisionally in the select list 2016.

**11. Smt. Nalini, K. (DT/JS Rank No. 4562)**

VC-05/14/TSR has been registered against her in connection with the irregularities in the issuance of Permit for transporting river sand.

Another Vigilance Case vide No. 13/15/TR has also been registered against her alleging the sanction of illegal mutation. Prosecution Sanction Order has not issued.

Meantime memo of charges for Major penalty has also been issued by the Government, against her vide No. 66168/D2/14/15 in the same matter. Not submitted the Confidential Report. The Committee decided to supersede her.

**12. Sri A. Unni Raja (DT/JS Rank No. 4572)**

Disciplinary action has been initiated by the Government by issuing minor Memo of Charges, vide No. 20768/D1/12/RD dated 20-3-2014 in connection with the recommendation of Vigilance surprise check report for inordinate delay in mutation.

The main charge levelled against him is that while he was working as Village Officer, Azhoor, lot of P. V. application were kept in bundle without accounting the same in the registers concerned and failed to take time bound action (LRD3-15845/14). The Committee decided to include him provisionally in the Select List 2016.

**13. Sri Anilkumar, K. S. (DT/JS Rank No. 4574)**

Minor Memo of charges has been issued by the District Collector, Thrissur vide No. SS1-38024/12.

Minor Memo of Charge has been issued by the District Collector, Thrissur vide No. SS1-38024/12 dated 29-6-2012. The main charge levelled against him was that while he was working as Deputy Tahsildar/Junior Superintendent, Taluk Office, Chavakkad, he prepared erroneous D. C. B. Statement to submit before the D.C.B. conference conducted by the Commissioner of Land Revenue. Not submitted the Confidential Report. The committee decided to supersede him.

**14. Sri Satya Prakash, P. V. (DT/JS Rank No. 4578)**

CR not submitted. The committee decided to supersede him.

**15. Sri M. Babu (Rank No. 4591)**

A criminal case vide No. 56/13 is registered against him under Section 118, 120(b), 143, 147, 148, 149, 294(b), 323, 341 of I.P.C. He is the 9th accused in the above criminal case.

In another case he was placed under suspension by the District Collector, Idukki vide proceedings No. SS2-15550/2015 dated 9-4-2015. In connection with unauthorized absence for a period of more than 3 months. At present he has been re-instated in to service by the District Collector, Idukki vide proceedings No. SS2-15550/2015 dated 15-9-2015.

Besides, he has not submitted the Confidential Report yet. The committee decided to supersede him.

**16. Sri N. Krishna Shenoy (DT/JS Rank No. 4598)**

Disciplinary action have been initiated by the Government by issuing Memo of Charges for major penalty Vide No. 25845/D2/14/RD dated 23-7-2014.

The main charges levelled against him is that while he was working as Junior Superintendent of Taluk Office, Thalassery, (C) Section his negligence caused inordinate delay in realizing the Building Tax and Luxury Tax in time. Another charge is that he did not inspect the personal registers of his section properly. His date of birth is 22-7-1958.

The committee decided to supersede him.

**17. Varghese, P. S. (DT/JS Rank No. 4407)**

His name not considered in the previous DPC for want of required qualification. He attained required qualification during November, 2015. The Committee considered his merit and ability and decided to include him in the Select List 2016.
