In accordance with Government Orders read as 1st and 2nd, Kerala Revenue Service Special Rules were published. Rule 7 of Kerala Revenue Service (Tahsildars) Special Rules published as per Government Order read as 2nd above, stipulates in that, every person appointed as Tahsildar, shall from the date on which he/she joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

According to Rule 8 of the Kerala Revenue Service (Tahsildar) Special Rules read as 2<sup>nd</sup>, every person appointed as Tahsildar, shall, before declaration of completion of his/her probation successfully, undergo Magisterial training for eight weeks (6 weeks in the Police Department and 2 weeks in the Judicial Department) as detailed in the Annexure to these Rules, if he has not undergone the training before appointed to the service.

The Kerala Revenue Service (Tahsildar) Special Rules amended with regard to Government Order read as 3rd, envisaging that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be as one year on duty within continuous span of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation as emphasized under Rule 8 of the Special Rules (Tahsildar).

The District Collectors submitted proposal as per reference read as 4th to declare the probation of Tahsildar/Senior Superintendents who completed Police and Magisterial Training in due course. On examination of the reports as stated, probation of Tahsildar/Senior Superintendent attached to the list appended to have satisfactorily completed in the forenoon of the date as shown in the column number nine of the list.
