In accordance with the Government Order read 1st and 2nd above, Kerala Revenue Special Rules were published. According to Rule 7 of Kerala Revenue Service (Tahsildars) Special Rules published as per Government Order read as 2nd above, every person appointed as Tahsildar shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

Rule 8 of the Kerala Revenue Service (Tahsildar) Special Rules read as 2nd above envisaged that every person appointed as Tahsildar shall, before declaration of completion of his/her probation successfully, undergo Magisterial training for a period of 8 weeks (6 weeks in the Police Department and 2 Weeks in the Judicial Department) as detailed in the Annexure to these rules, if he has not undergone the training before appointment to the service.

In pursuance to the Government Order read as 3rd, the Special Rules were amended and envisaged that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be as one year on duty within a continuous period of two years and the person who appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation as directed under Rule 8 of the Special Rules.

As per the proceedings read as 4th, temporary promotions in the cadre of Tahsildar/Senior Superintendent for the period from 01-04-2001 to 31-12-2010 have been regularized in accordance with judgments of the Hon'ble Court, Government Orders and Rule 28 b(i) of K.S. & S.S. R. The final seniority list in the cadre of Tahsildar/Senior Superintendent for the period from 01-04-2001 to 31-12-2010 has been published vide proceedings read as 5th above.

In accordance with the references read as 1 to 5 above, probation in the cadre of Tahsildar/Senior Superintendent enclosed in the list appended are declared to have satisfactorily completed in the forenoon of the date as shown in the column number nine of the list.
