As per Government Order read as 1st and 2nd above. Kerala Revenue Special Rules were published. Rule 7 of Kerala Revenue Service (Tahsildar) Special Rules published as per Government Order read as 2nd above emphasized that every person appointed as Tahsildar shall, from the date on which he/she joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

Rule 8 of the Kerala Revenue Service (Tahsildar) Special Rules read as 2nd above envisaged that every person appointed as Tahsildar shall, before declaration of completion of his/her probation successfully, undergo Magisterial Training for a period 8 weeks (6 weeks in the Police Department and 2 weeks in the Judicial Department) as detailed in the Annexure to these rules, if he has not undergone the training before appointment to the service.

The Kerala Revenue Service (Tahsildar) Special Rules were amended as per Government Order read as 3rd above, emphasized that the period of declaration in the cadre of Tahsildar/Senior Superintendent shall be as one year on duty within a continuous period of two years and the person who appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation as directed under Rule 8 of the Special Rules.

All temporary promotions in the cadre of Tahsildar/Senior Superintendent for the period from 1-4-2001 to 31-12-2010 have been regularized as per proceedings read as 4th above, in compliance with judgments of Hon'ble Court, Government directions and Rule 28 b(i) of KS

& SSR. In furtherance to the regularisation proceedings the final seniority list of Tahsildar/Senior Superintendent for the aforementioned period has been drawn and published vide proceedings read as 5th above.

In accordance with the references read as 1 to 5 above, probations in the cadre of Tahsildar/Senior Superintendent enclosed in the list appended are declared to have satisfactorily completed in the forenoon of the date as shown in the column number nine of the list.
