Sub :- Establishment – Land Revenue Department – Declaration of Probation in the cadre of Tahsildar/Senior Superintendent– orders issued

The Kerala Revenue Service (Tahsildar) Special Rules amended as per Government Order read as 1st paper above, states that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be one year on duty within a continuous span of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training for eight weeks before declaration of probation as emphasized under Rule 8 of Special Rules (Tahsildar).

The District Collector, Idukki has submitted proposal read as 2nd paper above, for the declaration of probation in the cadre of Tahsildar/ Senior Superintendent in respect of Sri.P.P.Joy who has completed Police and Magisterial Training. In the proposal the reason for the extension probation period is also clarified. As per the letter read as 3rd paper above, the District Collector, Kozhikkod has submitted proposals for the declaration of probation in respect of Sri.K.Pradeep Kumar, Sri.MohanKumar.K.A and Sri.K.Raveendran.

Considering the proposals submitted by the District Collector, Idukki and Kozhikkode, the probation period in respect of Sri.P.P.Joy and Sri.K.Raveendran are here by extended up to 02.10.2016 and 05.10.2016 respectively.

In the circumstances, the Probation of Tahsildars/Senior Superintendents named below are declared to have satisfactorily completed on the Forenoon of the dates shown against their names in Column No.9.
