As per Government Order read 1st and 2nd above, Kerala Revenue Service Special Rules were published. Rule 7 of Kerala Revenue Service (Tahsildars) Special Rules published as per Government Order read as 2nd above, emphasized that every person appointed as Tahsildar, shall, from the date on which he/she joins duty, on probation for a total period of two years on duty within a continuous period of three years.

Rule 8 of the Kerala Revenue Service (Tahsildar) Special Rules read as 2nd above envisaged that every person appointed as Tahsildar, shall, before declaration of completion of his/her probation successfully, undergo Magisterial training for total period of 8 weeks (*6 weeks in the Police Department and 2 Weeks in the Judicial Department*) as detailed in the Annexure to these rules, if he has not undergone the training before appointment to the service.

Kerala Revenue Service (Tahsildar) Special Rules amended as per Government Order read as 3rd above, envisaged that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be as one year on duty within a continuous period of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training before declaration of probation as directed under Rule 8 of the Special Rules.

As per the proceedings read as 4th above, all temporary promotions in the post of Tahsildar/Senior Superintendent from 01-04-2001 to 31-12-2010 have been regularized in compliance with judgments of the Hon'ble Courts, Government Orders and Rule 28 b(i) of K.S. & S.S.R.1958. In furtherance to the final seniority of Tahsildar/Senior Superintendent for the aforementioned period has been drawn and published vide proceedings read as 5th above.

In accordance with the references read as 1 to 5 above, probation in the cadre of Tahsildar/Senior Superintendent enclosed in the list appended are declared to have satisfactorily completed in the forenoon of the date as shown in the column number nine of the list.
