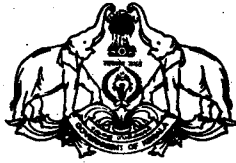

NOTIFICATION

No. LR-E2-2900/2017. Dated, Thiruvananthapuram, 31st May, 2017.

The Departmental Promotion Committee (Lower) was convened on 31-5-2017 to draw up the Select List for the year 2017.

The Departmental Promotion Committee (Lower) considered the requests of Smt. Beena P. Anand and Sri Anilkumar, B. K. and decided as follows:

1. Sri Anilkumar, B. K. (Rank No. 4279)

The DPC held on 4-8-2015, 8-12-2015 and 15-6-2016 has superseded him due to non submission of Confidential Reports. Subsequently he has submitted the CR on 4-11-2016 and therefore, the DPC held on

14-12-2016, decided to include him in the Select List for the year 2016 as Sl. No. 84A between Rank No. 84 and 85. Against this decision, Sri Anilkumar, B. K. submitted a request to review the position allotted to him in the Select List. Committee discussed the matter in detail and as the non inclusion of the candidate was due to non submission of CR at the right time and as the previous DPC has already considered this aspect, the Departmental Promotion Committee decided to agree with the decision of the last DPC.

## **2. Smt. Beena P. Anand (Rank No. 4521)**

Since disciplinary action for major penalty has been initiated by the Commissioner, she had been superseded by the DPC held on 15-6-2016. Later the Commissioner of Land Revenue has finalized the disciplinary action vide proceedings No. LR-D6-27079/15 dated 19-8-2016, as the incumbent remitted the excess amount drawn as TA. Hence the ad hoc DPC held on 14-12-2016 decided to include her in the Select List for the year 2016 as 84B, in between Sl. No. 84A Sri Anilkumar, B. K. and Sl. No. 85 Sri Hamsath, S.

Against this decision, Smt. Beena P. Anand submitted a request to review the position allotted to her in the Select List.

Committee examined the related files and came to a decision that as the incumbent was not fully exonerated from the charges, her request deserves no consideration.

The DPC (Lower) reviewed the cases which are provisionally included in the Select List for the year 2016 and took following decisions:

### **1. Sri Babu, S. (Rank No. 4374)**

The Vigilance and Anti Corruption Bureau has registered a case against him as per V.C. 01/14/KLM and prosecution sanction order has also been issued as per proceedings No. LRD3-6316/114 dated 22-6-2015 by the Commissioner of Land Revenue. The case is still pending before the Vigilance and Anti Corruption Bureau. Hence the DPC (Lower) convened on 28-7-2015 has decided to supersede him.

Against the decision of the said DPC, Sri Babu, S. filed a representation before the Convener, DPC (Lower) and Land Revenue Commissioner to review the decision of the DPC. This representation was disposed of with the decision that the matter will be placed before the next DPC.

The DPC (Lower) held on 15-6-2016 considered his representation and since the charge sheet has not been issued so far, the DPC decided to include him provisionally in the Select List for the year 2016 subject to the report of the VACB.

DPC discussed the case in detail. Since the Vigilance case is still pending and prosecution sanction has already been issued, the DPC decided to continue the present status.

## **2. Sri Jayajose Raj, C. L. (Rank No. 4419)**

As per the Government Order G.O. (Rt.) No. 3194/2004/RD dated 19-8-2001, LWA for study purpose was sanctioned to Sri Jayajose Raj, C. L. subject to the terms and conditions specified in Appendix XII B, Part I, KSR. Aggrieved by this order he filed an OA bearing No. 1912/15 before the Kerala Administrative Tribunal requesting to review the above Government Order. The OA was disposed on 18-11-2015 with a direction to the Government to consider and pass orders on the representation of the petitioner.

Government have examined the matter and orders issued accordingly vide G. O.(Rt.) No.1959/16/RD dated 3-3-2016. On the basis of this Government Order, the Land Revenue Commissioner re-examined the seniority position in the posts of the HC/RI/VO and DT/Jr. Superintendent and re-assigned the rank position of Sri Jayajose Raj, C. L.

As per proceedings No. LRT1-20001/15 dated 4-4-2016 the seniority position of Sri Jayajose Raj, C. L. has been assigned as Rank No. 4419 in the Seniority List for the period from 1-1-2009 to 31-12-2013. Departmental Promotion Committee considered his case in detail and came to a unanimous opinion that the said G.O. needs a review. However, the DPC decided to include his name provisionally in the Select List for 2016 and decided to request the Government to review the said Government Order.

As per the decision of the DPC, the Commissioner of Land Revenue has requested Government to review the Order No. 1959/16/RD dated 3-3-2016. The Government as per letter No. 51829/T3/2017/RD dated 20-3-2017 informed that there is no need to review the said order.

DPC (Lower) discussed the matter in detail and unanimously opined that there is every possibility to attract similar representations from those who availed LWA for study purpose which may cause administrative inconvenience and affect the seniority of many employees.

Hence the meeting decided to submit a detailed report before the Government in this regard to re-examine the said G.O. and to keep the present status until the next DPC.

### **3. Sri Gopalakrishnan, K. K. (Rank No. 4445)**

V.C 03/14/KNR has been registered against him with regard to the issuance of bogus pattayam. Prosecution sanction order not issued so far. The DPC held on 15-6-2016 decided to include him provisionally in the Select List 2016. The provisional inclusion of the incumbent in the Select List for 2016 is reviewed by the DPC and decided to keep the status until the next DPC (Lower).

### **4. Sri Nadharshan, V. P. (Rank No. 4549)**

Disciplinary action for minor penalty has been initiated against him vide Memo of charge No. 48255/D1/14/RD dated 25-11-2014 in connection with the irregularities in quarrying. The DPC (Lower) held on 15-6-2016 decided to include him provisionally in the Select List 2016. Since the disciplinary action initiated against him has been dropped vide Government Order No. 48255/D1/14/RD dated 21-11-2016, the committee decided to include him permanently in the Select List for 2016.

### **5. Sri Unniraja, A. (Rank No. 4572)**

Disciplinary action has been initiated by the Government by issuing minor Memo of Charges vide No. 20768/D1/12/RD dated 20-3-2014 in connection with the recommendation of Vigilance surprise check report for inordinate delay in mutation.

The main charge leveled against him is that while he was working as Village Officer, Azhoor, lot of P. V. applications were kept in bundle without accounting the same in the registers concerned and failed to take time bound action (LRD3-15845/14). So the DPC (Lower) held on 15-6-2016 decided to include him provisionally in the Select List for the year 2016.

Now as per G.O. (Ms.) 3535/16/Rev. dated 30-8-2016 the Government have finalized the case by awarding a censure to the incumbent. DPC discussed the matter and decided to include him permanently in the Select List for 2016.

The DPC (Lower) then reviewed the cases of supersession by the previous Departmental Promotion Committees and decided as follows:

**1. Sri Mohandas, G. (DT/JS Rank No. 4531)**

The incumbent has qualified the Higher Survey examination vide Certificate No. 274/16 dated 27-6-2016 and Criminal Judicial Test vide Certificate No. 13389/13 dated 5-11-2013.

Vigilance case is pending against him as V.C4/14/PKD. Memo of charges for imposing major penalties has been issued by the Government as per letter No. 87014/D2/15/RD, dated 6-4-2016. Another Vigilance case No. VC-7/14/PKD is also pending against him for the illegal conversion of land. Prosecution sanction order has not been issued. DPC (Lower) discussed the matter and as there is no change in position, decided to continue his supersession.

**2. Sri Prabhullakumar, S. (DT/JS Rank No. 4544)**

Sri Prabhullakumar, S. was trapped by the Vigilance and Anti Corruption Bureau while accepting bribe. Vigilance case No. 03/08/KLM has been registered. Prosecution sanction order has been issued and he is convicted by Hon'ble court in CC 35/09. Pursuant to this, he has been suspended from service vide proceedings No. LR-D1-2138/17 dated 30-5-2017.

Committee discussed the case in detail and decided to exclude him from the field of choice as he does not deserve any merit.

### **3. Sri Saleendran, K. S. (DT/JS Rank No. 4546)**

Major Memo of Charge has been issued against him, vide No. LRD5-21241/10 dated 30-10-2014, by the Commissioner of Land Revenue with regard to the loss sustained to the Government due to short levy of building tax. The disciplinary action dropped as per the proceedings No. LR-D5-21241/10 dated 22-3-2017 of the Commissioner of Land Revenue. He failed to submit the Confidential Report.

The DPC (Lower) discussed the matter in detail. Since the incumbent is not an approved probationer and erroneously included in the field of choice for 2016, the DPC (Lower) decided to exclude him from the field of choice.

### **4. Sri Sathyaprakash, P. V. (DT/JS Rank No. 4578)**

Since the incumbent has not submitted the Confidential Report, the DPC decided to continue his supersession.

### **5. Sri M. Babu (DT/JS Rank No. 4591)**

A criminal case vide No. 56/13 has been registered against him under Section 118, 120(b), 143, 147, 148, 149, 294(b), 323, 341 of IPC. He is the 9th accused in the above criminal case. In another case he was placed under suspension by the District Collector, Idukki vide proceedings No. SS2-15550/2015 dated 9-4-2015, in connection with unauthorized absence for a period of more than three months. Subsequently he has been re-instated in service by the District Collector, Idukki vide proceedings No. SS2-15550/2015 dated 15-9-2015. He was not an approved probationer and was erroneously included in the field of choice of 2016. Besides this, he has not submitted the confidential report.

Since his probation has not been declared, the DPC decided to exclude him from the field of choice.

The Departmental Promotion Committee further considered the merit and ability of the officers included in the current year's field of choice and decided as follows:

**1. Sri Jithesh Babu, K. T. (Rank No. 4644)**

Even though the incumbent is qualified, he failed to submit the Confidential Report. Hence DPC decided to supersede him.

**2. Sri Shajahan Rawther (Rank No. 4649)**

Disciplinary action initiated by Government is pending against him. Memo of charges for major penalty has been issued (File No. 3344/D1/16/RD). Hence Committee decided to supersede him.

**3. Sri Sreekumar, K. (Rank No. 4651)**

Disciplinary action was initiated against him by the Government on the ground that he has issued possession certificate and sketch of the same property for two different persons while working as Village Officer, Pathanamthitta.

DPC discussed the matter in detail. The disciplinary action initiated against him for major penalty has been finalized by Government by barring one annual increment without cumulative effect as per G.O. (Rt.) No. 1060/17 dated 14-03-2017.

Since the currency period of the penalty is not completed, the DPC decided to supersede him.

**4. Smt. Geetha, K. G. (Rank No. 4670)**

Even though the incumbent is qualified, she has not submitted the Confidential Report. Hence DPC decided to supersede her.

**5. Sri Bharathasenan, V. V. (Rank No. 4700)**

Disciplinary action was initiated and memo of charges for major penalty issued against him by the Government on the ground that no action was taken to prevent the filling of soil on the wetland and no follow up action was taken on the petition submitted by the Secretary, Ponnani Taluk Paddy Field Protection Council.

DPC discussed the matter in detail. The disciplinary action initiated against him has been finalized by Government by barring two annual increments without cumulative effect as per G.O. (Rt.) No. 2573/16/RD dated 17-6-2016. Since the currency period of the penalty is not completed, the Committee decided to supersede him.

**6. Sri Ajayakumar, T. M. (Rank No. 4707)**

Disciplinary action for minor penalty has been initiated against him by the Commissioner of Land Revenue. Memo of charges issued vide file No. LR-D3-48665/13(2) dated 2-3-2017. DPC discussed the matter in detail and considering the lesser gravity of the charges leveled against him, decided to include him in the Select List for the year 2017.

**7. Smt. Jaya, V. C. (Rank No. 4794)**

Even though the incumbent is qualified, she has not submitted the Confidential Report. Hence the DPC decided to supersede her.

**8. Smt. Suma, K. S. (Rank No. 4795)**

Even though the incumbent is qualified, she has not submitted the Confidential Report. Hence the DPC decided to supersede her.

**9. Sri Radhakrishnan, S. (Rank No. 4799)**

Show cause notice issued by the District Collector, Palakkad for causing inordinate delay in disposing of files. Reply to the notice has been submitted by the incumbent. Charges has not yet been framed. DPC discussed the matter in detail and decided to include him in the Select List for the Year 2017.

**10. Sri Ramasan, P. V. (Rank No. 4815)**

Even though the incumbent is qualified, he has not submitted the Confidential Report. Hence DPC decided to supersede him.

**11. Smt. Bindu, P. G. (Rank No. 4867)**

Even though the incumbent is qualified, she has not submitted the Confidential Report. Hence DPC decided to supersede her.

**12. Sri Shaji, C. K. (Rank No. 4875)**

Disciplinary action for minor penalty initiated by the District Collector, Kannur is pending against him vide file No. 2008/46592/13. DPC discussed the matter in detail. Even though the disciplinary action has not been finalized, considering the lesser gravity of the charges leveled against him, the DPC decided to include him in the Select List for the year 2017.



**13. Smt. Sunitha Jacob (Rank No. 4882)**

Even though the incumbent is qualified, she has not submitted the Confidential Report. Hence DPC decided to supersede her.

**14. Sri Ani, B. P. (Rank No. 4886)**

Memo of charges for major penalty has been issued to him. Even though the incumbent is qualified, he has not submitted Confidential Report. Hence the DPC decided to supersede him.

**15. Sri Sabu, M. G. (Rank No. 4925)**

Two Vigilance cases No. VC-14/08/IDK and VC-06/07/IDK are pending against him. Prosecution sanction were issued in both cases. Hence the DPC decided to supersede him.
