The Kerala Revenue Service (Tahsildar) Special Rules amended as per Government Order read as 1st paper above, states that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be one year on duty within a continuous span of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training for eight weeks before declaration of probation as emphasized under Rule 8 of Special Rules (Tahsildar).

As per the letters read as paper 2 to 12, the District Collectors/Head of Offices concerned have submitted proposals for the declaration of probation of Tahsildars/ Senior Superintendents who have satisfactorily completed Police and Magisterial training.

Based on the reports submitted by the District Collectors concerned, and the reasons shown in column 7 and 8, the probation period of the incumbents numbered as sl.nos 5 and 7 are hereby extended up to the dates shown against their names in Column No.9.As per the proceedings read as paper 13 above, the probation period in respect of Smt. Lethakumari.C, has been extended for one year and subsequently as per the Government order read as paper 14 above, Government have extended the period of probation up to 30.03.2017.

In these circumstances, the Probation of the following Tahsildars/Senior Superintendents are declared to have satisfactorily completed on the Forenoon of the dates shown against their names in Column No.10.


