The Kerala Revenue Service (Tahsildar) Special Rules amended as per Government Order read as 1st paper above, states that the period of declaration of probation in the cadre of Tahsildar/Senior Superintendent shall be one year on duty within a continuous span of two years and the person who is appointed as Tahsildar shall undergo Police and Magisterial Training for eight weeks before declaration of probation as emphasized under Rule 8 of Special Rules (Tahsildar).

Considering the requests, the probation period in respect of Sri.Sudheesh.R, and Sri.PradeepKumar.G are here by extended up to 18.02.2017 and 01.02.2017 respectively.
