The Government of Kerala hereby make the following amendments to the Transfer of Registry Rules, 1966 issued as notification under GO(P) No 490/66 dated, 14th September, 1966, and published in the Kerala Gazette No 40 dated, 11th October, 1966, namely.

AMENDMENT

In the Transfer of Registry Rules 1966,- for clause (vi) of sub-rule (a) of rule 3, the following shall be substituted; namely:-

(vi) "The Registering Officer shall see that the application for transfer of registry are forwarded to the Tahsildar/Village officer in a complete form. In the villages notified from time to time under the National Land Records Modernisation Programme, the application in Form 1B appended to this Rules should be forwarded online wherever possible for effecting transfer of registry"

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport).

For the smooth implementation of the online Transfer of registry envisaged under the National Land Records Modernisation Programme, appropriate changes in the relevant Statues are to be made. Majority of the procedures and guidelines contemplated for effecting Transfer of Registry warrants immediate amendment in Transfer of Registry Rules, 1966 for meeting the requirements of online Transfer of Registry and to meet statutory requirements envisaged under Rule 30 (iv) of Registration Rules (Kerala), 1958. Besides, as per the Government order G.O (P)No 24/2010/ITD dated 04/08/2010, Government is free to initiate appropriate steps towards ensuring Electronic Delivery Services (EDS)

This notification is intended to achieve the above object.
