As per the Government Order (10th Pay revision Order of Kerala State Government Employees) 1<sup>st</sup> cited, the pay scale of HC/RI is revised as Rs 27800- 59400 and the Village Officer Rs 29200- 62400 with effect from 01.07.2014. In this circumstance, Village Officer and HC/RI cadres in Revenue department has to be separated with effect from 01.07.2014 according to the cadre strength of each category. This is possible only after the amendment of Revenue Ministerial Sub Ordinate special Rule in view of the GO 1<sup>st</sup> cited. Now about 50 HC/RI vacancies are existing in various districts. If the said vacancies are not duly filled it may adversely affect the functions of this department and forthcoming General Election to Legislative Assembly. To overcome this situation, following senior most UDC/SVO who are included in the seniority list read as 1<sup>st</sup> above are promoted in the cadre of HC/RI on temporary basis under Rule 31 of KS & SSR.
