G.O.(P)No.58/2023/RD

The Departmental Promotion Committee (Higher) for Revenue Department met on 20.02.2023 in the chamber of the Chairman for preparing the select list of Tahsildars eligible for 'by transfer' appointment to the cadre of Deputy Collector under Kerala Civil Service (Executive), for the year 2023.

At the outset, the cases of the following officers who were superseded by the previous Ad-hoc DPC (H) meeting held on 30.11.2022 were reviewed.



1. Sri.Joy.P.P. (Rank No.1384)

Sri.Joy.P.P was superseded by the last DPC on account of the currency period of punishment imposed.

Disciplinary action for major penalty against Sri.Joy.P.P initiated by the Government in connection with an enquiry report of Survey Vigilance Wing regarding the malpractices in files relating to LRM cases while he was officiating as Additional Tahsildar, Udumbanchola was culminated in barring three annual increments with cumulative effect as per G.O.(Rt) No.2751/2022/RD dated 23.06.2022. DPC observed that the officer is under the currency period of punishment. Hence DPC has unanimously decided to supersede Sri.Joy.P.P from including in the select list.

The committee has also decided to supersede the following officers who were included in the filed of choice of the select list for the year 2023 for the reasons given therein.

1) Geethak K V (Rank No.1772)

The officer was expired. Hence DPC decided to supersede him from the Select List.

2) Ranjith P K (Rank No.1777)

The officer was expired. Hence DPC decided to supersede him from the Select List.

3) Smt.Letha P A (Rank No.1822)

The Officer has not submitted the Annual Confidential Report. Hence DPC decided to supersede her from the Select List.

4) Sri. Mustafa Kamal K M (Rank No. 1825)

(i) A disciplinary action for major penalty was initiated against Sri.Mustafa Kamal K M while he was officiating as LR Tahsildar at Manjeswaram Taluk in Kasargod District in connection with the findings of V&ACB inspection team. The above disciplinary action was finalized by awarding censure vide G.O(Rt)No.1951/2022/RD dated 29.04.2022.

(ii) A Vigilance Case No.16/16/EKM was registered against the officer in connection with the approval of location certificate prepared by the Village Assistant without site inspection at Araykkapadi Village, while he was officiating as Village Officer. A departmental proceedings was initiated against him and served with memo of charges and statement of allegations. The same was temporarily dropped with a condition that the disciplinary action will be resumed according to the final order of the



vigilance case. Considering the pendency of vigilance case DPC has decided to supersede him.

5) Sri.George Joseph (Rank No.1826)

A Vigilance Case No.VC 6/2022/TSR is registered against the officer in connection with land assignment to M/s.Thomson Granites Pvt Ltd, Thrissur by violating Land Ceiling Rules. According to the recommendation of V&ACB the officer was suspended from service vide G.O. (Rt)No.594/2023/RD dated 06.02.2023. Hence DPC decided to discard his candidature for inclusion in the select list and hence superseded.

6) Sri.Gokul Das K (Rank No.1849)

Sri.Gokul Das K was served with memo of charges and statement of allegation in connection with irregularities in building tax assessment in Kozhikode District in Government file no.D4/310/2018-Rev. Subsequently a provisional decision for barring his 3 annual increments with cumulative effect was made and show cause notice was served on the officer. After examining the case DPC decided to supersede him.

7) Sri.Afsal B (Rank No.1852)

(i) Disciplinary action for major penalty was initiated against the officer in connection with the issuance of certificates for the land coming under the KLR Act at Vythiri Taluk in Wayanad District. Government is awaiting enquiry report from the enquiry officer.

(ii) A disciplinary action for major penalty initiated by District Collector, Palakkad in connection with the issuance of fake possession certificate by carrying out malpractices in land records was finalized on 10.10.2022 by barring 3 annual increments of the officer with cumulative effect. His appeal against the above punishment is pending before the Commissioner of Land Revenue. A stay for the operation of order of District Collector is granted by the Commissioner of Land Revenue till the disposal of the appeal petition.

Considering the gravity of reported disciplinary actions DPC has unanimously decided to supersede the officer from including in the select list.

The committee made thorough scrutiny of the Annual Confidential Reports of the officers included in the field of choice and assessed the merit and ability of each officer. As per the report of the convener there are 22 anticipated vacancies of Deputy Collectors this year. DPC observed that 5 officers supposed to be included in the select list is also retiring this year itself. Hence DPC has recommended to draw the Select List of 31 Tahsildars for the year 2023 for “by transfer appointment” to the cadre of Deputy Collector for the year 2023 as



given below. The vacancies arise out of retirement, deputation and VRS can be filled up from this Select List.
