S. R. O. No. 797/2016.—In exercise of the powers conferred by sub-section (1) of section 51 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala, hereby establish the Land Acquisition, Rehabilitation and Resettlement Authority in the area

of jurisdiction specified in column (3) of the schedule, in consultation with the High Court of Kerala, and hereby notify Additional District and Sessions Courts mentioned in column (2) of the Schedule below to perform the functions of the said Authority under the said Act within the area specified in column (3), namely:—

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), has come into force in the State with effect from 1st January, 2014. The said Act provides the State Government shall, for the purpose of providing speedy disposal of disputes relating to land acquisition, compensation, rehabilitation and resettlement, establish, by notification, one or more authorities to be known as "Land Acquisition, Rehabilitation and Resettlement Authority", to exercise jurisdiction, powers and authority conferred on it by or under this Act. Therefore Government have decided to establish the Land Acquisition, Rehabilitation and Resettlement Authority in the area of jurisdiction specified in column (3) of the schedule above in consultation with the Chief Justice of the High Court of Kerala and to notify Additional District and Sessions Courts mentioned in column (2) of the schedule to perform the functions of the said Authority under the said Act.

The notification is intended to achieve the above object.
